### **Manager comment**

In the 3d quarter interest rate expectations were key factors influencing market performance driving valuations higher.

The 4th quarter 2025 market perspectives show a mixed outlook with US stock valuations fully priced in, while Europe and Emerging markets show opportunities in targeted sectors. The US economy faces slowing growth and persistent inflation, with potential headwinds from fading stimulus and tariffs, yet it is supported by strong innovation and corporate earning uplift.

The Global economy is experiencing slowing growth. However, AI investment and monetary policy easing are providing support. Sticky inflation, fueled by tariffs, continues to be a challenge worldwide. We think that future stock performance will largely depend on corporate earnings growth. Therefore, we are maintaining a resilient portfolio focusing on technology innovations such as AI and Blockchain developments, Small cap Stocks which are beneficiaries of a rate cut environment, with diversification through options like physical metals (Silver). 


